**Provider and the recipient must meet the definition of "Behavior Focus" as defined in the Developmental Disabilities Home and Community-Based Services Waiver Coverage and Limitations handbook to qualify for this rate.

Rate Considerations: Rates are based on 365 days of operation, with 350 possible billing days available per year. The monthly rate for this service shall be used by the provider if the recipient is in the home 24 or more days per month, and cannot be used in combination with the daily rate in a given calendar month. When a recipient is admitted into, or discharged from a licensed facility during the month, the daily rate shall be used during the month of discharge or admission by the admitting or discharging facility for the days the individual is present at the respective facility. When being admitted or discharged, the facility where the recipient is residing at 11:59 PM on the date of admission will bill for that particular day. The Daily Rate is limited to no more than 23 days in a given month.
